

GERMAN INFLUENCER SHOT BY POLICE IN AMSTERDAM

This is what the autopsy report says
The investigation of his death brings new mysteries

Wetzlar/Amsterdam - The death of fitness influencer Sammy B. (23) from Wetzlar (Hesse) is becoming more and more mysterious!

The young man was shot dead by police officers in Amsterdam (Netherlands) last August - although he was reported missing and was mentally confused.

Until now, it was unclear whether Sammy was on drugs at the time of death.

BILD now has exclusive access to the forensic report!

The result: Sammy had only 0.0011 mg/l THC in his blood and had not taken any other intoxicants.

It is therefore a vanishingly small amount of cannabis. For comparison: In Germany, this value is the limit to drive a vehicle.

From the expert report: "Based on the results of the toxicological examination, it cannot be concluded that alcohol, drugs, medication or pesticides influenced consciousness/behavior at the time of death."

What happened?

Last August, Sammy went to Amsterdam with friends to celebrate his 23rd birthday on August 11. But on the night of his birthday, the health and fitness trainer disappeared without a trace. His family reported him missing to Amsterdam police, saying he was mentally confused and needed medical help.

No one knows to this day where Sammy was between August 11 and 13. But: on August 13, police officers discovered him in a backyard. A resident had filmed the event and posted

the video on the Internet. In it, the young man can be seen walking up and down, half-dressed and confused, allegedly with a large knife in his hand. The armed officers, eight in all, approached him - to no avail.

When he turned his back on them, a police officer with a dog tried to subdue him - and failed. Sammy lay on his back, screaming and thrashing about. Then four shots rang out - three of which killed Sammy!

What we know today

Sammy's mother Justine (49): "Sammy was with his friends the night before his birthday in a so-called coffee shop. There they smoked a joint and bought a muffin in which cannabis was baked. Sammy shared it with a buddy. A short time later he became strange, did not react to his friends and disappeared. This was completely untypical behavior for my son. He was always very reliable, never took drugs, never even drank alcohol. He was probably curious and wanted to try something out. He has always lived an extremely healthy life, which is probably why his body overreacted so much. We believe that he developed a sudden psychosis with paranoia and could not get out of it on his own. That's why we also indicated in the missing person report that he was mentally confused and needed medical help."

Psychologist Christian Luedke (60) also confirms the possibility of psychosis. He says: "Young people underestimate the risk of cannabis. A single consumption is enough and even the smallest amounts can trigger a psychosis. So-called hyperthermia occurs, which means that the brain heats up, sometimes to over 40 degrees. This leads to irreversible damage, panic attacks and psychoses. The individuals lose touch with reality."

Sammy's sports doctor also came to know him as a healthy, vigorous man who had no contact with drugs. Orthopedist Dr. Alwin Sauer says in his statement, "He presented the image of an extremely ambitious and dynamic young athlete. He was very ambitious. Psychological abnormalities were never noticed by me. On the contrary, the young man appeared smart, differentiated and structured."

There are many inconsistencies

► **In the video from the Amsterdam backyard, Sammy can be heard asking for a doctor.** But the police officers did not allow a doctor to come, although a doctor and paramedics were standing nearby. And Sammy's mother was also standing just 250 meters away from the scene of the crime, Sammy's best friend at the fence that demarcated the backyard. Both offered their help several times to address Sammy, but no one let them. Even the officer in charge reportedly radioed that he was a patient, not a criminal.

► **There were eight police officers, with sharp, drawn weapons.** Sammy was alone. His mother Justine: "Surely it would have been easy for the police to overpower my son without shooting him. The whole operation took only about 15 minutes."



- ▶ **The officers justified their action with self-defense.** Sammy had a large knife with him and allegedly stabbed a police officer while he was lying on the ground. **However, later investigations revealed that Sammy was merely carrying a carving knife with a seven-centimeter blade, no police officer was injured, and no police officer's protective vest was damaged.** A statement from the prosecutor's office later said, "He ("the policeman," editor's note) described that the victim's knife passed close to his throat and arm."
- ▶ **The police shots hit Sammy's abdomen and chest from two meters away,** destroying his lungs, liver, and spleen, among others. Why didn't the officers shoot into his legs to incapacitate him?
- ▶ **One of the police officers had a bodycam with him which was supposed to film the entire operation.** Unfortunately, no recordings could be seen afterwards. According to the prosecutor's office, "The investigation team contacted the technician and he stated that due to a malfunction of the bodycam, no picture or sound was recorded." Sammy's mother has a different suspicion. She says, "We found out that the person wearing the camera and the police officer who fired the fatal shots at my son are private friends. Is this a coincidence or is there a cover-up going on?"
- ▶ **No neighborhood interviews were conducted as part of the investigation.** Only the officers on the scene and the journalist, who also lives in one of the surrounding houses and took the video that was later published on the Internet, were questioned. In this regard, from the statement of the prosecutor's office: "Since all statements are now generally supported and confirmed by the images, the conduct of the neighborhood investigation is no longer necessary."
- ▶ **The public prosecutor's office announced at the beginning of December last year that it wanted to make a decision regarding the filing of charges before Christmas.** In fact, to this day, there has been no official feedback as to whether or not legal action will be taken against the police officers. They are still on duty every day.

But no matter how long it takes, Sammy's parents do not want to give up, see their son as a victim of police violence and racism. After all, the young Influencer has African-American roots, his grandfather comes from the Caribbean island of Jamaica, later emigrated to the U.S. and served for the U.S. Army in Germany. Sammy's mother Justine: "Would the same have happened if Sammy had been a blond Dutchman? I don't think so!" Then, "**That was an execution squad!** We will keep fighting - until those responsible are brought to justice."
