# Autopsy Report of Sammy Baker Raises Questions!

## Intentional Killing?



Last August, German fitness influencer Sammy Baker died under curious circumstances during a police operation in Amsterdam. Even before his death, the young man had been reported missing. Why he disappeared at that time, however, was not clear. When he was finally found by officers in a backyard, the 23-year-old allegedly carried a knife and stabbed a police officer present in the protective vest, whereupon he was shot with three bullets. According to the police chief, the German man appeared confused and mentally unstable. Until now it was questionable whether the athlete was under the influence of drugs at the time of death.

However, a forensic report is now said to be available that rules out the use of intoxicants:

*"Based on the results of the toxicological examination, it cannot be concluded that alcohol, drugs, medication or pesticides influenced consciousness/behavior at the time of death."*

Accordingly, **only 0.0011 mg/l THC** was detected in the victim's blood. Justine, the mother of the deceased, explained the low dose of THC by a visit to a coffee shop, where her son **had come into contact with cannabis for the first time**. Before that, Sammy **had not consumed drugs or alcohol**. From this, the 49-year-old concluded a **psychosis** caused by the drug, which is said to have triggered a persecutory **delusion** in her son. Psychologist Christian Lüdke also believes this to be possible in an interview with the BILD newspaper. According to the web star's treating orthopedist, there were no similar incidents or psychological problems before.



Even if the confusion can be logically justified to a certain extent, many questions still seem to be unresolved. For example, **Sammy is said to have asked for a doctor, but the police had not taken into account either this or the offer of help from his mother and best friend, who were in the immediate area**. This is evident from a video from the said incident. The fact that the officers attribute their actions to self-defense also seems quite

questionable, since later investigations have shown, on the one hand, that **Sammy was only carrying a carving knife and, on the other hand, that no damage to the protective vest could be proven.**

In general, it seems **extremely dubious that eight armed police officers failed to subdue a confused young man and instead fired shots at his abdomen and chest instead of aiming at his legs**, thus incapacitating him. Furthermore, it was allegedly planned to record the entire operation by means of a **bodycam**, but this was allegedly not successful due to a **technical defect**. The BILD newspaper reports that the officers also ignored the supposed advice of the officer in charge that **Baker was not a criminal**.

**Given the above information, Sammy Baker's mother, Justine, is talking about an execution squad. Nevertheless, nine months later, the investigation does not seem to have been finally concluded. Also, the decision on filing a lawsuit against the responsible officers is said to be pending to this day. For the parents of the man who was shot, the last word has also not yet been spoken, because they see their son as a victim of police violence and racism.**

Under the slogan "Justice for Sammy", numerous people took to the streets to defend Sammy's honor.
